The Parkinson Foundation of the National Capital Area (PFNCA) improves the quality of life of those impacted by Parkinson's disease, their care partners and families, and fosters a sense of community to ensure that no one battles this disease alone. Full mission on Schedule O.

Support & education programs: PFNCA provided extensive educational programming for families impacted by Parkinson's disease during Fiscal Year 2015. A monthly Community Lecture Series was held in both Rockville, Maryland and Fairfax, Virginia. Sample topics included increasing productivity, all-inclusive care, hospitalization, benefits of massage therapy, speech therapy, home accessibility and new medications. With the leadership of its Medical Advisory Board, PFNCA also produced an all-day educational Symposium attended by more than 650 people.

4b (Code:) (Expenses \$ 108,251. including grants of \$) (Revenue \$)
Weekly programs: A large part of PFNCA's service emphasizes allowing those diagnosed with Parkinson's disease to slow the negative aspects of how the disease makes them feel. Key components of this effort include movement (exercise, yoga and dance) and vocal cord strengthening (communications club and choir) programs.

During Fiscal Year 2015, PFNCA offered program sessions at no cost for people impacted by Parkinson's disease who reside in Washington, D.C., Maryland and Virginia. These programs were offered at 20 different locations in 13 cities.

Public awareness: PFNCA works to raise awareness within our community about Parkinson's disease. The Foundation's newsletter -- Parkinson Update -- features articles on new treatments, coping with the disease, and promising research advances. PFNCA also produces an electronic newsletter and maintains a website with educational resources.
