



Education programs & support: PFNCA provided extensive educational programming for families impacted by Parkinson's disease in Fiscal 2021. Programming continued to be provided online in response to COVID-19. A Lecture Series was held online. Topics included: The Future of Parkinson's Treatments and Make the Most of Your Visit with your Movement Disorder Specialist. PFNCA also provided its annual educational conference - the PFNCA Symposium. Developed by PFNCA's Medical Advisory Board, the event was held as an online view on demand conference with more than 40 sessions from 35 physicians that specialize in Parkinson's.

Wellness classes/programs: A large part of PFNCA's service emphasizes allowing those diagnosed with Parkinson's disease to slow the negative aspects of how the disease makes them feel. Key components of this effort include movement (exercise, boxing, yoga and dance) and voice strengthening (communications club and choir) programs. During Fiscal Year 2021, PFNCA offered program sessions at no per session cost for people impacted by Parkinson's disease who reside in Washington, D.C., Maryland, Virginia and elsewhere.

Public awareness: PFNCA works to raise awareness within our community about Parkinson's disease. The Foundation's e-newsletter - PD Info for You helps educate readers about the disease.
