A Doctor of Osteopathy's Perspective on Parkinson's

Alphabet of Dysautonomia in PD: Autonomic dysfunction, Bladder problems, Constipation, Dizziness and Erectile dysfunction

This presentation covers a group of non-motor symptoms of Parkinson's disease that are very common and often affect quality of life a lot, even though they are not always recognized as symptoms of Parkinson's. Specifically, we will discuss problems with dizziness in an upright position (due to low blood pressure), bladder (urge with urination), constipation and erectile dysfunction in men. We will talk about the symptoms many of our patients experience and what we can do to address these problems.

Atypical Parkinsonism
