Education programs & support: PFNCA provided extensive educational programing for families impacted by Parkinson's disease in Fiscal Year 2025. PFNCA produced its annual educational conference - the PFNCA Symposium. Developed by PFNCA's Medical Advisory Board, the event was held online June 28, 2025. Additional lectures were provided using an online view on demand format. Lectures included Translating what is in the news to living with Parkinson's today, Medical Management of PD, Surgical and non-invasive options, Alphabet of dysautonomia in PD: Autonomic dysfunction, Bladder problems, Constipation, Dizziness and Erectile dysfunction, Unusual behaviors in Parkinson's Disease, Atypical Parkinsonism, Treatment case studies, Benefits of Exercise, A Doctor of Osteopathy's Perspective on Parkinson's, (continued in Sch O)

Wellness classes/programs: A large part of PFNCA's service emphasizes allowing those diagnosed with Parkinson's disease to slow the negative aspects of how the disease makes them feel. Key components of this effort include movement (exercise, boxing, yoga and dance) and voice strengthening (communications club and choir) programs. During Fiscal Year 2025, PFNCA offered program sessions at no per session cost for people impacted by Parkinson's disease who reside in Washington, D.C., Maryland, Virginia and elsewhere. In FY25, more than 2,600 wellness class sessions were provided. Classes focused on various types of exercise (seated, high aerobic, boxing, dance, etc.) and maintaining communication skills. Public awareness: PFNCA works to raise awareness within our community about Parkinson's disease. The Foundation's e-newsletter - PD Info for You helps educate readers about the disease. PFNCA also produces print materials and maintains a website with educational resources. One popular aspect of the organization's website is the Parkinson's Scorecard, developed by PFNCA to share information to help people diagnosed with Parkinson's get a snapshot of their knowledge of considerations when living with the disease. PFNCA's Community Outreach Vehicle and mascot (AMP) attended several events in FY25 to raise awareness of living well with Parkinson's. (continued in Sch O)

The PFNCA Symposium included presentations by 19 physicians that specialize in Parkinson's (Movement Disorder Specialists) who represented Johns Hopkins University, Georgetown University, National Institutes of Health, George Washington University, the Cleveland Clinic, the University of Florida, Christiana Care, Inova and other practices.

The organization's Walk Off Parkinson's program took place October 6, 2024, and included lectures from physicians, exercise demonstrations and question and answer sessions. Lecture topics at this program included Surgical Options: How Movement Disorder Specialists and Surgeons Collaborate to Support You, What's Next: Information for Those Newly Diagnosed or Just Now Focusing on Their Diagnosis, Overview of Parkinson's, and Benefits of Attending A Support Group. Many physicians attended the program allowing for attendees to ask questions in an informal setting. The program also included a ceremony where people who attended 50 or more PFNCA wellness classes in the previous year were honored.

PFNCA also supported a network of more than 45 support groups for those impacted by Parkinson's. Additionally, PFNCA led several support groups designed for people newly diagnosed during FY25.

Classes were provided online and in-person. PFNCA's wellness classes also encourage socialization to combat isolation that people with Parkinson's may experience.
